Cole presented the June 2017 meeting calendar noting the GHS Golf Outing will be held on Monday, June 26, 2017 at the Davison Country Club. Cole also presented the minutes from the April meeting of the Region 10 Board of Directors. There was a discussion at the meeting regarding the PA2 Liquor Tax dollars, which should be coming to GHS but haven't so far. Russell stated we just finished a proposal for use of the PA2 funds and will present to the Region 10 Board at their June 16th meeting

VII. Executive Director's Report

D. Russell presented his report, noting there were informational documents included on both state and federal issues, along with an informational letter regarding the 298 proposal. Russell discussed a partnership with Greater Flint Health Coalition called the SIM project to attempt to address the high utilization of hospital emergency rooms. We are looking to place two navigators, possibly in the hospitals.

Russell also highlighted that lead abatement teams are going door to door in the city of Flint, and that Wayne State, with GHS assistance, is conducting the largest Legionella study ever in Flint.

Russell also met with the new County Chair. It was a good meeting, but there are still unresolved issues.

VIII. Other Business

Shultz wanted to recognize the staff who put on the GHS Dance. She said it was a very well-run event and our consumers really enjoyed themselves.

Naomi Schmult from the GHS Consumer Council asked why there is such limited funding in Genesee County for people with traumatic brain injuries (TBI).
