## **ANNUAL REPORT TO THE COMMUNITY 2018**

We are pleased to present our report to the community for 2018. The year continued to be a very busy at GHS. The number of individuals served continued to climb to over 12,000 individuals with a mental health or intellectual/developmental disability. Almost 5,800 individuals received primary care services through our Federally Qualified Health Center, Genesee Community Health Center.

GHS still continues to be involved in the recovery effort from the Flint Water Crisis. In spite of some funding ending, we have continued to provide services to hundreds of residents each week because of our long standing commitment to the community. We will continue to provide these services as long as they are needed. 2018 also saw the finalization and development of the Neurodevelopmental Center of Excellence (NCE), with the goal to provide a specialized neuropsychological assessment to all children who were impacted by the water crisis. With continued funding, the NCE will identify issues that affect Flint children into the future.

Another important development that occurred in 2018 was the beginning of the state wide 298 Pilot. 298 is a project to study the integration of behavioral health services and primary care, by integrating CMHs with the Medicaid Health Plans. The pilot, originally scheduled to start 10-1-18, has been pushed back to 10-1-19. GHS applied for and was awarded one of the three pilot slots along with Saginaw CMH, HealthWest (Muskegon CMH) and West Michigan CMH (Oceana, Mason and Lake Counties). The pilot will run for two or three years, and the pilot CMHs will work with the Medicaid Health Plans in their respective counties instead of the current PIHPs.

The 298 Pilot could be one of the most important initiatives ever in the state wide behavioral health system, as the outcomes will be evaluated, and the future direction of the system could be decided.

The GHS Board approved our participation in the pilot knowing that it would be a tremendous amount of work, but also with the knowledge that it could improve the care that our consumers receive, with better access to and collaboration with physical health. It will be several years before we know the results, but we remain committed to being involved in the process to redesign the system.

Whatever challenges in the ever changing healthcare environment we face, we will always continue to provide the very best, accessible care to the consumers and families of our community.

#### **Our Vision**





## **GCHC EVENTS FY 2018**


