### **Corwin Legleitner**

GHS will amend the contract with Corwin Legleitner for psychological services to increase the hourly rate to \$65.00/hour. The amendment will be effective 4/1/25 through 9/30/25.

### Eleos Behavioral Health AI (Artificial Intelligence) Software

GHS will contract with Eleos to provide behavioral health AI technology software to generate clinical progress notes. Eleos was chosen because of its expertise in behavioral health and proven integration with GHS's electronic health record. The rate for this service is based on \$89 per month per user. The contract will be evaluated annually based on user experience, expected efficiency and utilization criteria. The annual contract amount will be based on IT budget and the contract will begin upon contract approval.

#### **Precious Places LLC**

GHS will contract with Precious Places LLC to provide CLS services in semi-independent living arrangements. The standard CLS rate is \$6.37 per unit for 1:1 service delivery and \$3.19 per unit for 1:2 staff ration. The contract will be effective April 1, 2025, through September 30, 2026.

### Westwood Specialized Residential LLC- Out of Network Specialized Residential

GHS will contract with Westwood Specialized Residential LLC to accommodate an emergency placement for one individual who is currently in the ED and requires specialized residential care. The per diem is \$750.00/day and will be effective March 21, 2025, through September 30, 2025.

#### RFP/Purchasing

### First Day Homecare, LLC -DBA First Day ABA Therapy

As a result of an open procurement RFP process, First Day Homecare, LLC- DBA First Day ABA Therapy is selected to provide autism services focused to serve children within their home and in community settings while supporting hours outside of normal business hours, after school, early mornings, evenings, and weekends. Standard ABA rates apply, and the contract is effective April 1, 2025, through September 30, 2026.

### **Vestis Services, LLC**

GHS will contract with Vestis Services, LLC to provide a linen rental and launder service in support of the GHS CRU and CSU. The contract is available under the GPO Vizient, a governmental purchasing organization. The rate for the service is based upon selection from a variety of products and frequency of utilization. The annual contract amount will be monitored by budget. The 12-month contract will become effective on or about May 1, 2025.

#### VII. Executive Directors Report

Presented by Danis Russell, CEO

Russell invited Cheryl Rousseau, Director of ORR to the meeting today. Cheryl has announced her retirement after 29 years of service with Genesee Health System. Cheryl's last day was on Friday March 14, 2025. Under Cheryl's leadership, the GHS Office of Recipient Rights has earned 8 consecutive perfect scores on the triennial audits performed by the Michigan Department of Health and Human Services Office of Recipient Rights. In her time at GHS, Cheryl has overseen the investigations of over 13, 000 Recipient Rights complaints at GHS. The GHS Board would like to thank Cheryl for her 29 years of dedicated service to GHS staff, consumers, and their families, and wish her well in her retirement.

Russell discussed the Michigan Executive Budget Proposal; it is attached in the board packet for review.

In addition, Russell discussed the Federal Budget. Russell states that the President and the House Speaker have repeatedly argued that they are not targeting Medicaid cuts, saying that savings will come from reducing fraud and implementing work requirements. Russell states we have already see effects of these cuts in housing and food banks.

Next Russell passed out and discussed an informational packet regarding Michigan's Medicaid.

Lastly, Russell discussed that GHS has submitted a proposal to provide all health care to inmates in the Genesee County Jail. Initially it was just going to be behavioral health, but Jean Troop and GCHC agreed to also submit for primary care. Russell stated that it would be a challenging contract, but added that the inmates are Genesee County Residents, and regardless of why they are there, their services should be provided by a local provider.
