## **Contracts**

### **1. New**

#### **Hope Shores Stanley**

GHS will contract with Hope Shores Stanley home to provide specialized residential services under a single-case agreement for a GHS client to accommodate an emergent placement. The Contract is effective December 15, 2025 through September 30, 2026.

### **2. Amendment**

#### **DCW Minimum Wage Increase 2026**

GHS will amend the standard rates for all OHSS providers to incorporate the \$1.25/hour (0.31/unit) DCW minimum wage increase that takes effect January 1, 2026.

#### **Greater Flint Health Coalition (GFHC) – Flint Recast**

GHS will extend the current Mini Grant program with GFHC Flint Recast through calendar year 2026 at same terms as 2025, encompassing many focus areas of the millage all tied to health and wellness for vulnerable populations. All viable program applications will be awarded up to \$250,000. The contract term will be 3/1/2026 through 9/30/2026.

### **3. RFP/Purchasing**

As result of an open procurement process, six new Autism providers have been selected to provide ABA Services to serve eligible consumers. Standard ABA rates apply, and contracts will be effective 1/1/2026 through 09/30/2026.

#### **Food Bank of Eastern Michigan**

GHS will provide one-time funding in the amount of \$220,000 to the Food Bank of Eastern Michigan (FBEM) to disburse to several established food pantries in Genesee County identified

by FBEM as “most in need” of food and personal care items. This millage funding award falls under the priority focus area of health and wellness for vulnerable populations.

Winfrey moved; Howard-Coolin supported the motion to approve the one-time funding to the Eastern Food Bank as discussed.

#### **Warming Shelter Grants**

GHS will extend contracts with the 5 warming shelters in Genesee County to award additional grant funding up to \$50,000 each under the millage priority area of health and wellness for vulnerable populations. Funding is to be used for any or all the following areas: 1) serve additional people; 2) expand the capacity of hours of operation; 3) expand services; 4) funds to sustain the current capacity to serve the community. Contracts will be extended beginning January 1, 2026, through October 31, 2026.

- Shelter of Flint

Lastly Chipman reviewed the 2026 Millage Budget Summary report. A brief discussion followed.

### **R10 Report**

## **VIII. Executive Directors Report**

Presented by Danis Russell, CEO

Russell starts by stating that we are still waiting on Judge Yates judgement over the PIHP Procurement that MDHHS released. At the beginning of the month Judge Yates reviewed testimonies from both sides about the procurement. Judge Yates stated he would review all the information given and release a final decision in a couple of weeks.

Next Russell shared additional information along with the press release about GHS awarding grants to several local food pantries.

Next Russell states that the House recently cut \$600 million in grants and other programs throughout the state. This has affected some community partners already, this has not affected us yet, but this is very concerning. The Senate is trying to overturn this, but our lobbyists are saying they don't think they will be able to.

Russell states we had a good year in 2025, 2026 is going to be tough. A lot of changes and cuts will be challenging.

Next Russell states when we discussed the purchase of our New Main Campus buildings, one of the stipulations that were given was to have Christmas lights like Baker. Russell stated we had a Tree Lighting Ceremony 2 weeks ago. He took a photo from the ceremony and presented it to the Flint Township Board to show that we followed through on our commitment to the community's request.

Lastly, Russell invited the Board to the New Years Tea. The Tea is scheduled on Thursday January 22, 2026 from 1 pm to 4 pm. The Board meeting will directly follow.
